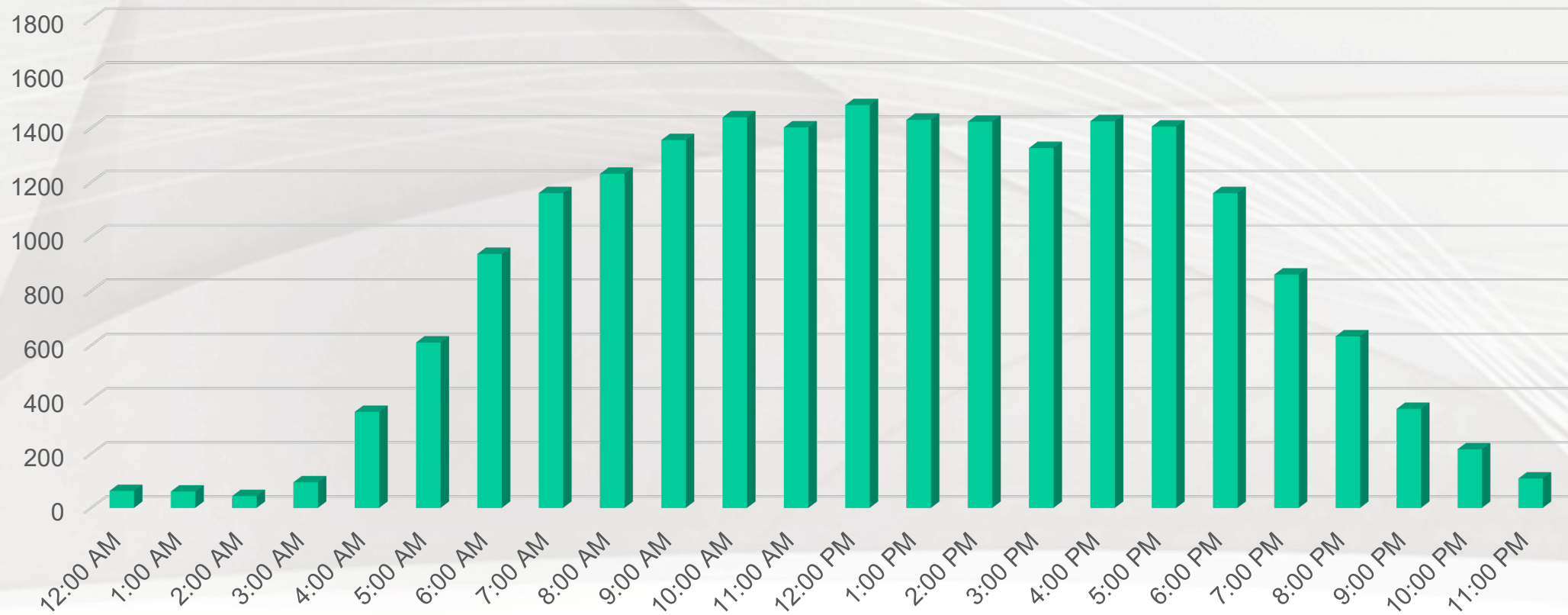

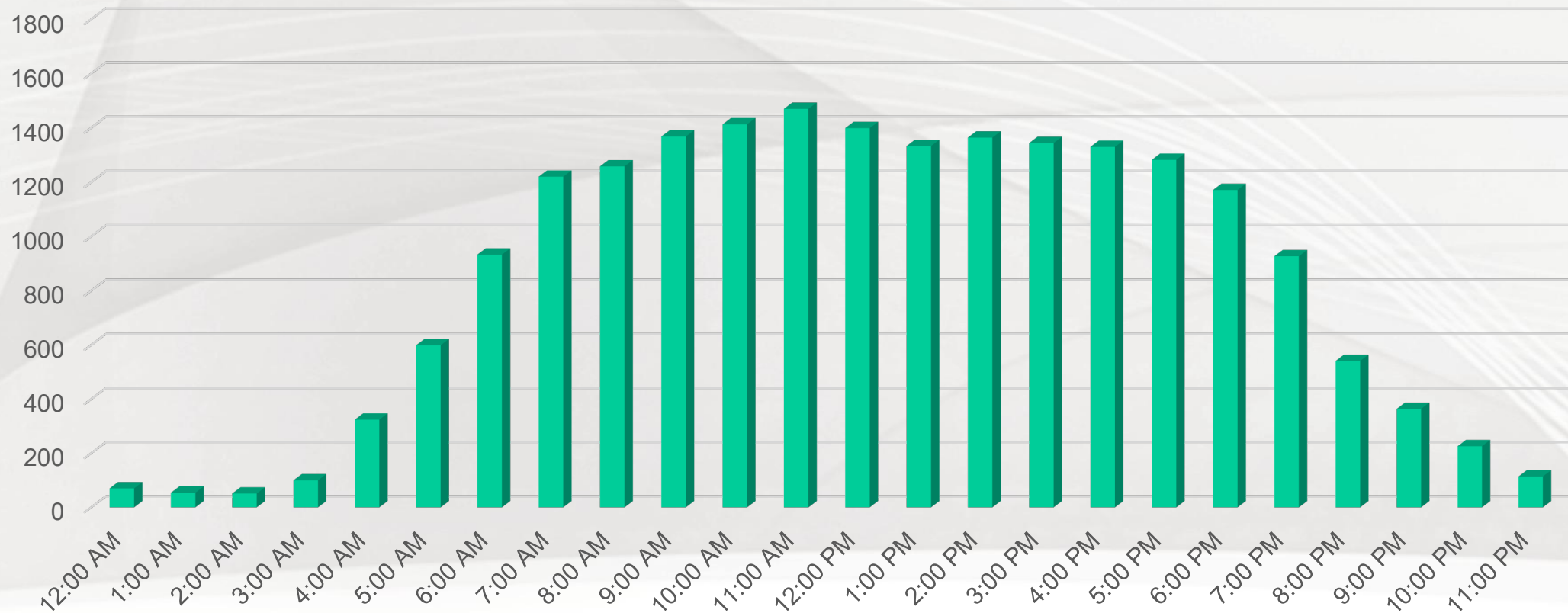
Traffic Flow



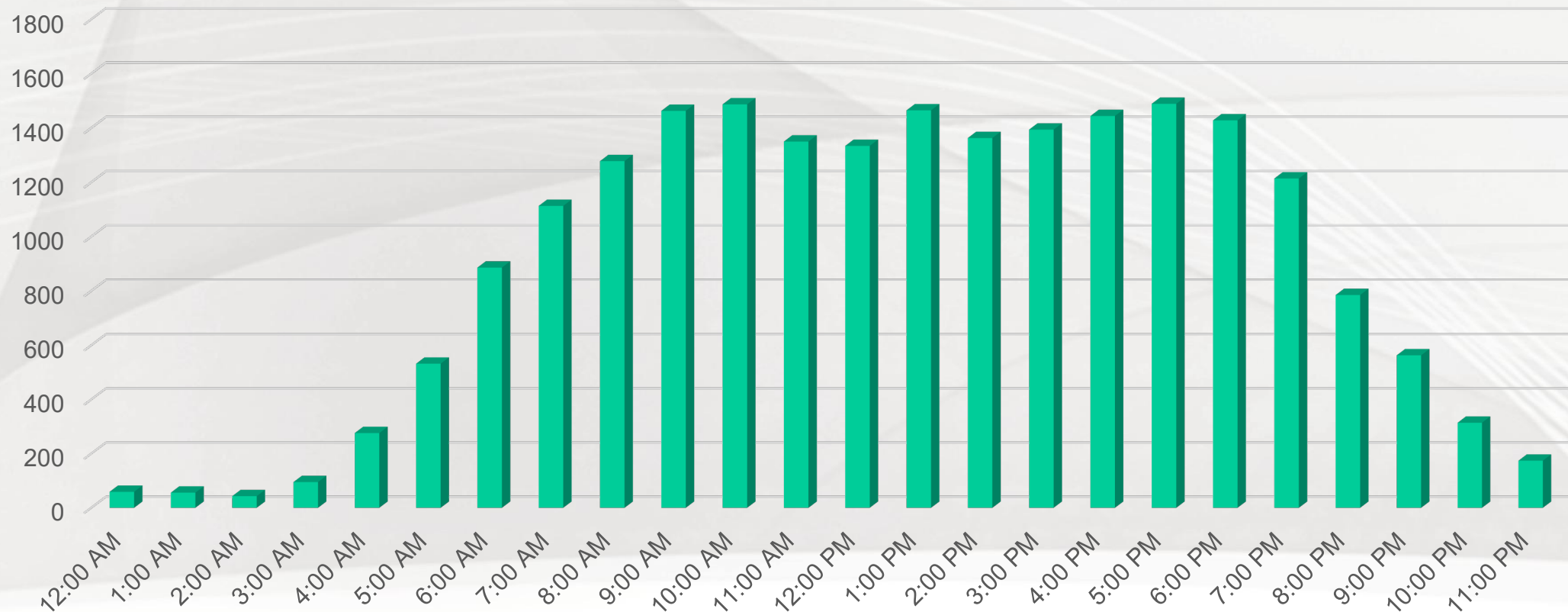
Route 1 Traffic Volumes - Wednesday August 12, 2020



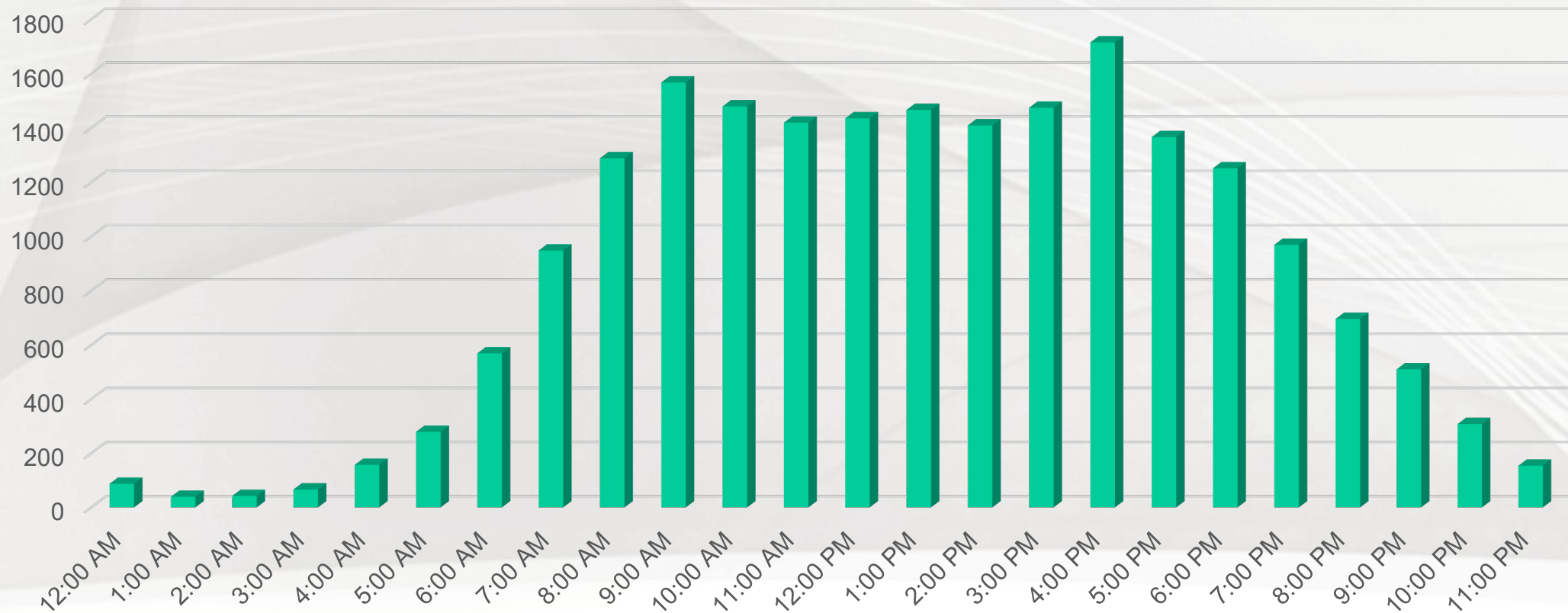
Route 1 Traffic Volumes - Thursday August 13, 2020

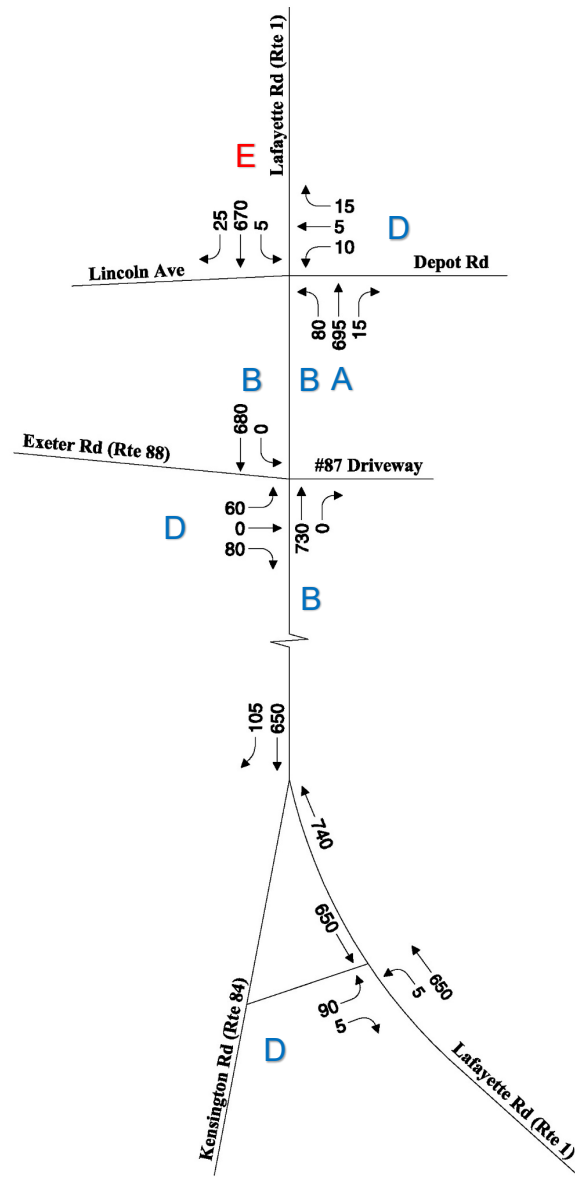


Route 1 Traffic Volumes - Friday August 14, 2020

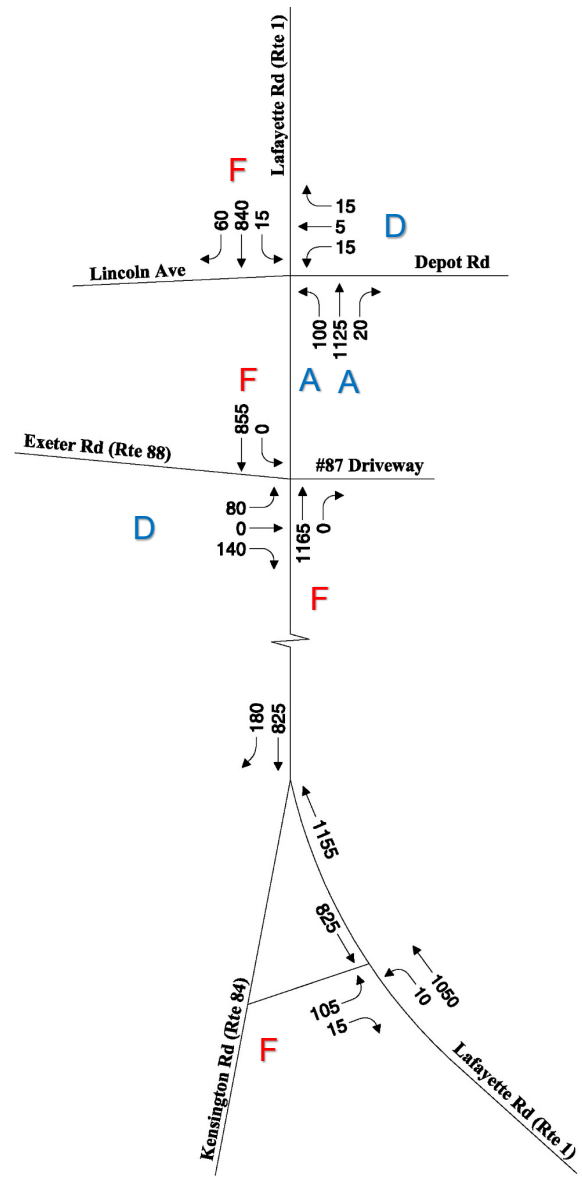


Route 1 Traffic Volumes - Saturday August 15, 2020

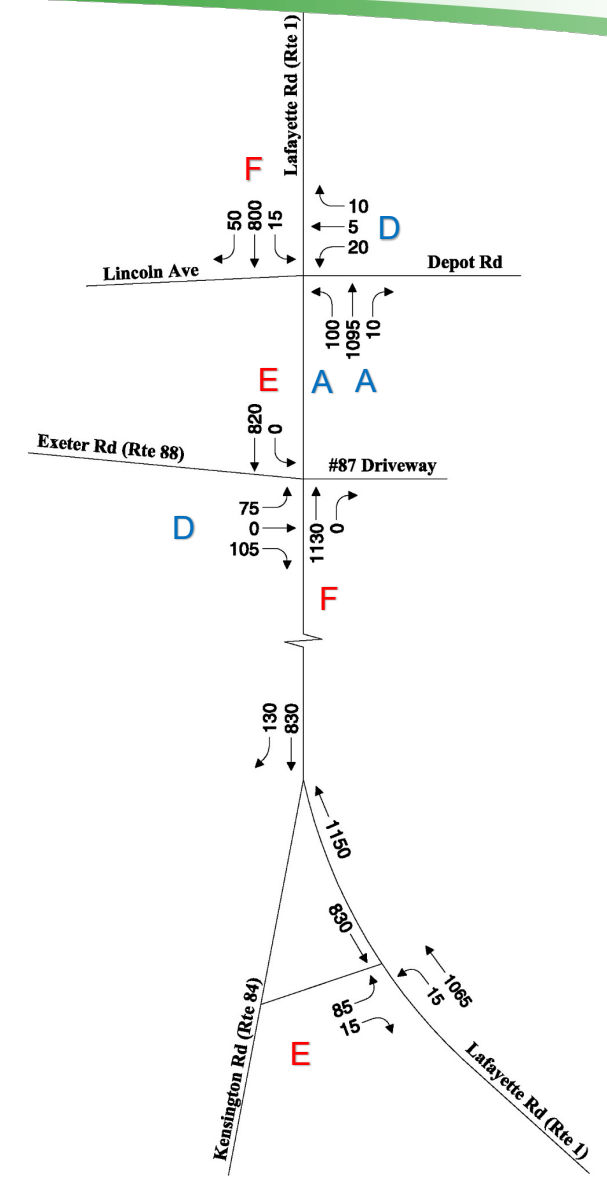




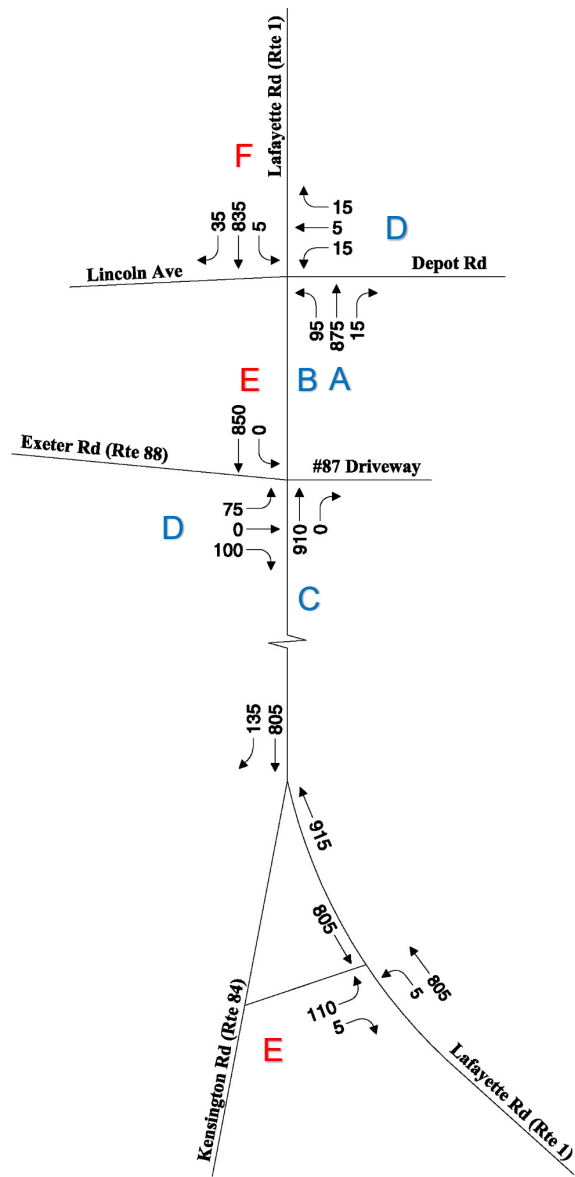
2020 Weekday
AM Peak Hour



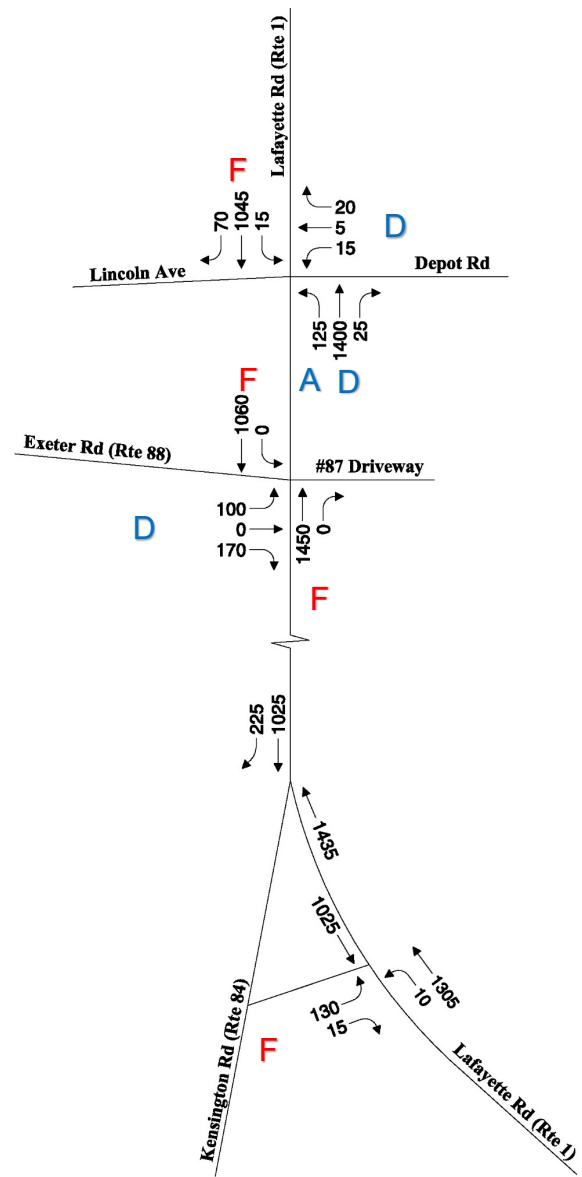
2020 Weekday
PM Peak Hour



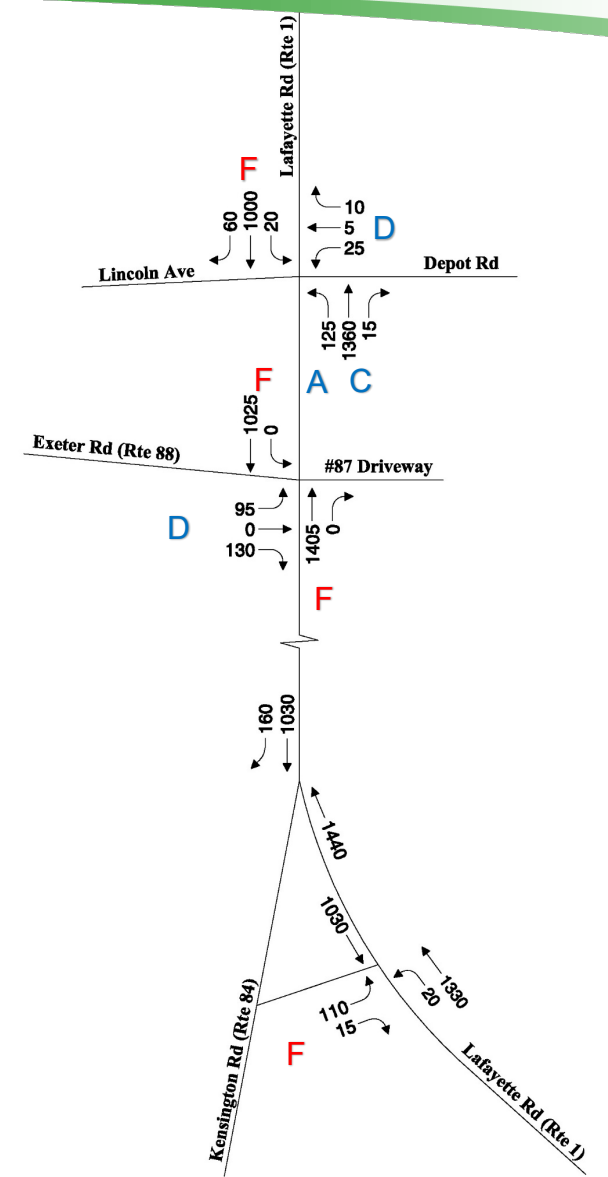
2020 Saturday
Mid-Day Peak Hour



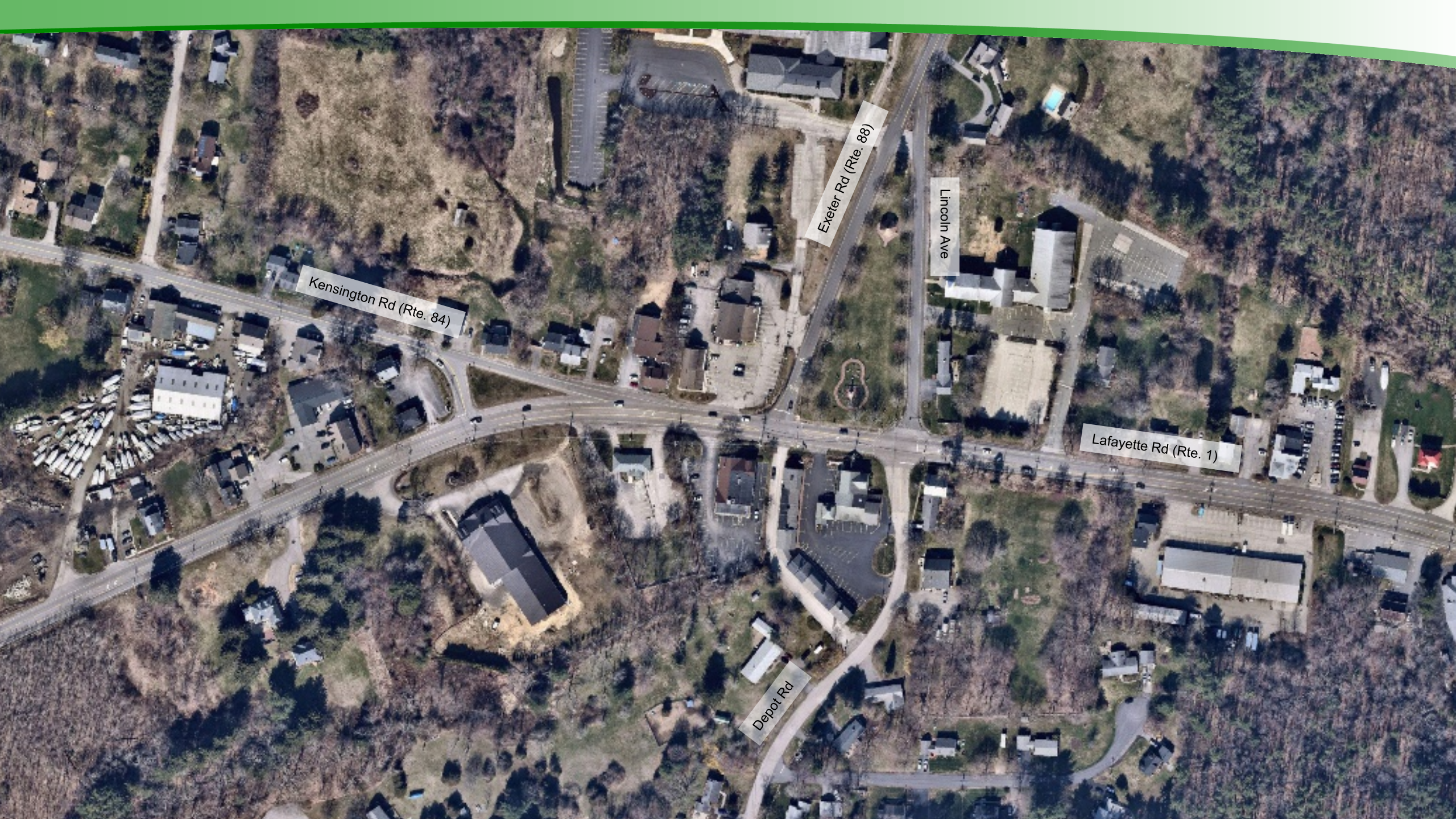
2042 Weekday

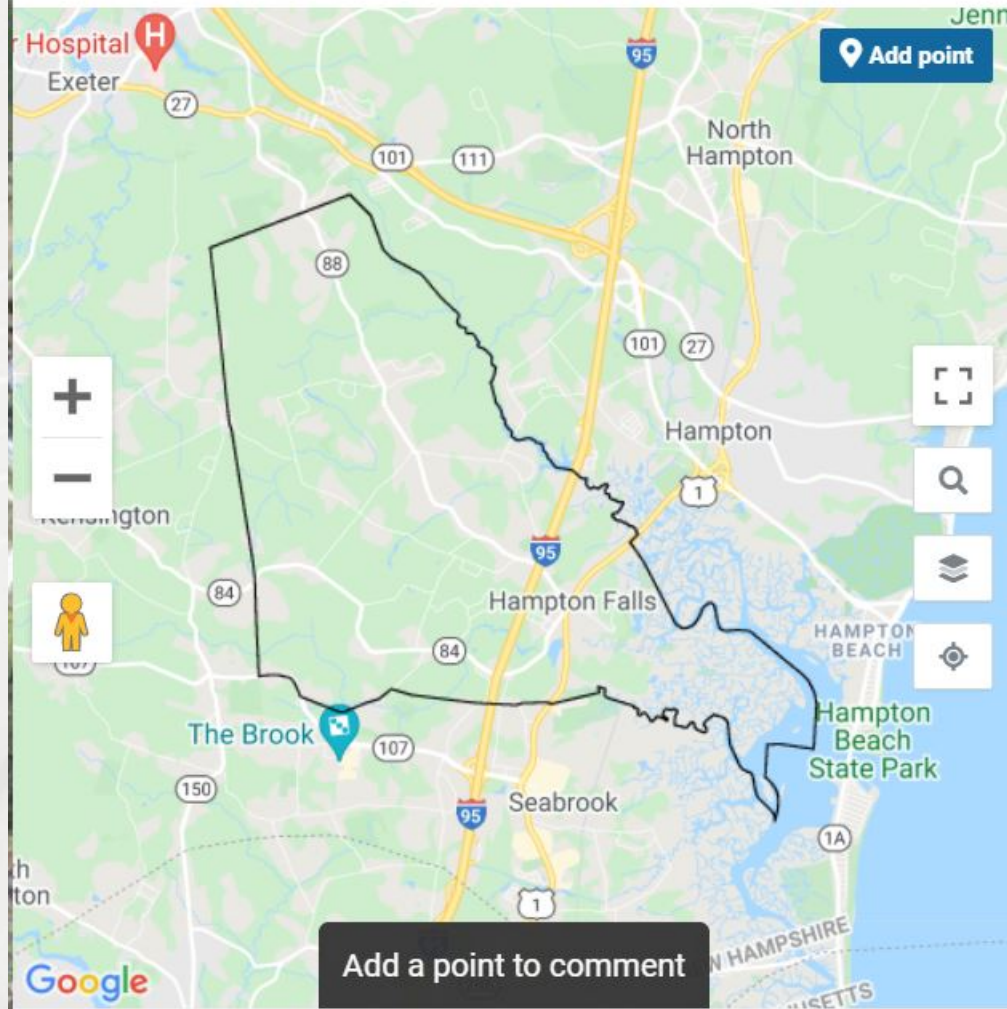

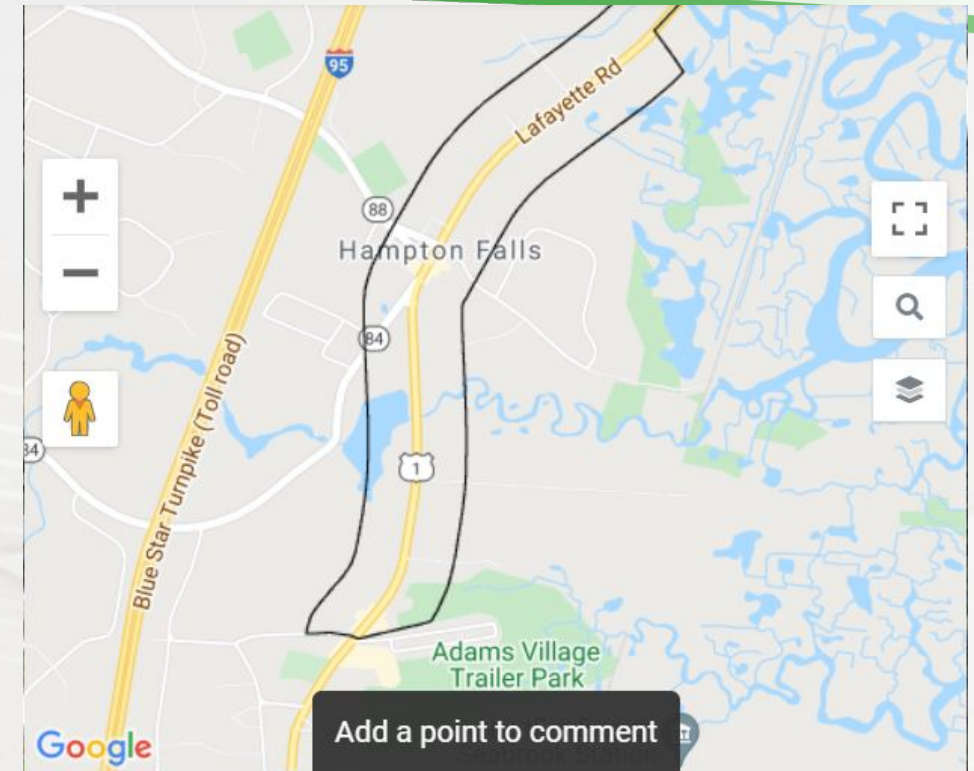
