The Commission would like to request \$2000.00 to purchase a set of flags for the Volunteer Color Guard team for patriotic days such as Memorial Day, Veterans Day, and Wreaths Across America Day. We request a full set of ceremonial flags which would include the American, Army, Navy, Air Force, Marine Corps, Space Force, Coast Guard, Merchant Marine, and POW flags.

The Commission would also like to request up to \$10,000.00 to update the container and surroundings at Governor Weare Park, including the painting of a mural on the outside of the container, setting up shelving on the inside, plantings in the outside area and setting up tables for the communities to use during the sporting events. This request falls under town beautification.

The Commission would like to have a spring clean up date to beautify the Governor Weare Park area. This will occur in conjunction with the Little Warriors Football club.

Ms. Donatelli has researched a cake decorating event with Katie's Custom Confections that would cost \$60 per person. Participants would leave with a decorated cake and learn new decorating techniques. There are kid events available, too, such as embroidered aprons. The cake decorating event will occur on April 18th, 2024, 6:30-8:30.
